## 2018 CAMPING INFORMATION AND REGISTRATION FORM

- 1. FEES: OVAS members pay \$30 (Must show proof of membership). Exhibitors pay \$50 and Non-exhibitors pay \$80. For daily rentals it is \$25 (this includes anyone in a site with electric & water). Self contained campers are \$20 during the fair. Rental is from Wednesday to Sunday. All fees must be paid before moving camper onto site. Passes for vendors and exhibitors are not included in this fee.
- **2. Water and electricity** are provided at each campsite. Excluded are the infield areas.
- 3. PASSES: Please go to the Pass Department for further information.
- 4. RESERVATIONS: All reservations and fees must be RECEIVED BY JUNE 25. THERE WILL BE NO EXCEPTIONS. Thereafter, all site requests will be filled on a first come first served basis. Reservations will be held only until 6 PM on Thursday (the first day of the fair) unless prior arrangements are made with the camping office. Checks will be made payable to Ossipee Valley Agricultural Society (OVAS).
- 5. CAMPER TRAILERS: Campers may not be brought onto the fairgrounds prior to Wednesday (the day before the fair begins) and must leave the fairgrounds by Monday evening (the day after the fair ends) unless other arrangements are made with the camping office. A \$25 per day fee will be charged for each additional day on the fairgrounds.
- **6. CAMPING ATTENDANTS** will assist you with locating your campsite and help guide you into the site.
- **7.** All overnight camping must be in the designated camping site you have reserved, unless prior arrangements are made with the Camping Office.
- **8. PARKING:** Only one vehicle is allowed at each campsite. All other vehicles will be towed at the vehicle owner's expense.
- **9. DO NOT PARK VEHICLES IN AN EMPTY CAMPSITE.** Illegally parked vehicles will be towed at the owner's expense.
- 10.NO PETS WILL BE ALLOWED ON THE FAIRGROUNDS EXCEPT SERVICE DOGS.
- **11.CAMPING RULES:** General campground rules and courtesies must be followed. Quiet time will be observed.
- 12.NO OPEN FIRES NO FIRE RINGS BARBEQUE GRILLS ONLY!
- **13.DUMPING STATION:** There is a dumping station at the rear of the fairgrounds. All waste water must be held in your holding tank. **NO WASTE WATER OR MATTER IS TO BE DUMPED ONTO THE GROUNDS.**
- **14.**The Ossipee Valley Agricultural Society (OVAS) will not be held responsible for cancellation of the fair due to circumstances beyond its control, nor be held liable for damages or thefts occurring during your stay on the fairgrounds, nor shall OVAS be required to refund fees paid.
- 15.ROADWAYS AND FIRE LANES MUST BE KEPT OPEN AT ALL TIMES FOR EMERGENCY AND SECURITY VEHICLES
